Mayor opened the floor to the public but first gave an overview of what the board has done to try and prevent the problems on the beach.

When notified of senior skip day NYS Police are notified as well they have come to the beach and been able to control the situation

Mayor Horan has reached out to Senator Griffo for any possible funding; Brian from the Senators office did contact the Mayor

Village has contracted out Sheriffs from 12-4 past Saturday and Sunday 5 tickets were written

Invited Capt Clark to attend tonight's meeting but she was unable to but did make some suggestions, they will have additional patrol on for the 4th and Pirates Weekend Contacted National Grid regarding pole that fell down on beach will be putting that back up

Looking into LED System with lights Monday, June 12th was just like the 4th of July

Mayor and village board listened to several residents in regards to their concerns and their safety of the activity happening on the beach. Dave Stirpe and Robert Johnson both indicated that they would donate to the village to have security for the beach. Other residents indicated that the village needs to spend the money and raise their taxes to get security. It was also suggested that the Village have a part time police department.

Under Sheriff Rob Swenszkowski addressed the public with their concerns and will give his full support to the village. He gave the public is phone # along with Chief Owens for them to contact if they need assistance.

GT Cornerstone Security Jarid Taciak and Jim Galler addressed questions from the residents and the board and informed everyone what they can do.

The Mayor indicated that he had approached the board before about suspending alcohol in the Sunset Park and at that time had received a petition from approximately 60 people that were against this idea. However, he still feels strongly and would like the board to consider suspending alcohol in the Sunset Park for this season.

The Mayor asked the board their opinion on what happened at tonight's meeting

It was everyone's feeling that by authorizing the extra Sheriffs and putting security on the beach was good start.

It was decided to commit to having 2 Oneida County Sheriffs for 5 hours a day on Saturday and Sunday during the hours of 1:00 pm until 6:00 pm which would include their half hour traveling time starting this coming weekend and through labor day weekend along with 5 extra days as needed and the board would like to reserve the right to call off at the Mayor's discretion. This would be an approximate cost of \$11,000.00 with a rate of \$69.00 per hour per person

Also, to have GT Cornerstone for private security to have 4 people on Saturday and Sunday to work same schedule with Oneida County Sheriffs and 2 people on Friday from 1:00 pm until 6:00 pm and 4 for the 4th of July the board would like to have reserve the right to call off at the Mayor's discretion as well. This would be an approximate cost of \$11,000.00 with a rate of \$35.00 per hour per person.

Motion was made by Trustee Clements and seconded by Trustee Shaughnessy for the safety and well being of the village residents and village tourist to authorize the village to contract with GT Cornerstone for private security and with the Oneida County Sheriffs as referenced above. Also, to authorize the Village Clerk to take \$25,000 for security purposes from the Oneida County Revenue Sharing. Carried as follows
