## Michael Sayles – Village Administrator

- Michael updated the Village Board on the Main St. Playground. The DPW has finished preparing the site ready for installation. Delivery of the playground is expected next week.
- Michael updated the Village Board on the Marina Dr./Birch Ln. sewer project. The contractors are in the last phase of construction, connecting the last part of the sewer pipe. The next step will be finishing the electrical work to the pump station and then dropping the new sewer pumps.
- Michael reported the leaf pickup is complete for the season. DPW has been working diligently.
- The DPW is currently working on and should have the Christmas decorations up this week.
- Michael updated the Village Board that there has been no response from the Fire Department on the letter that was mailed, therefore he has no update.
- Michael provided a "Financial Summary of Parking" to the Village Board members, as requested by the Mayor, which included figures for comparison from 2021 and 2022, and the totals from both seasons. It is evident that the investment made with pay stations that accept credit cards was the right decision. The next step would be updating the older machines with credit card capability.
- Interviews for the open positions at the DPW are ongoing and Michael hopes to have a decision by next week.
- Michael is currently busy with Codes Enforcement Training on his required hours.
- Trustee Lawrence asked Michael to thank the DPW for what a great job they have done on the Park.
- Trustee Daily inquired if Michael is looking into the erosion of sand in and around Main St. Park. Michael replied that he has been in contact with the DEC regarding replenishment.
