## **Resolutions:**

An application has been duly made to the Board of the Village of Sylvan Beach, County of Oneida, New York, by Time Warner Cable Northeast LLC, l/k/a Charter Communications, a limited liability company organized and existing in good standing under the laws of the State of Delaware doing business at 6005 Fair Lakes Road, East Syracuse, NY 13057, for the approval of commencing with the date of approval by the Public Service Commission.

The Franchise Renewal Agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Village of Sylvan Beach, New York on April 3, 2017 at 3:45 pm and notice of the hearing was published in the Rome Sentinel Paper on March 23, 2017.

NOW, THEREFORE, the Board of the Village of Sylvan Beach finds that:

- 1. Time Warner Cable Northeast LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Time Warner Cable Northeast LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Time Warner Cable Northeast LLC can reasonably meet the future cable related community needs and interest, taking into account the cost of meeting such needs and interest.

**BE IT FURTHER RESOLVED** that the Board of the Village of Sylvan Beach herby grants the cable television franchise of Time Warner Cable Northeast LLC and the Village of Sylvan Beach for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) years hence.

**BE IT FURTHER RESOLVED** by Trustee Sullivan and seconded by Trustee Shaughnessy that the Board of the Village of Sylvan Beach hereby confirms acceptance of this Franchise Renewal Agreement and hereby authorizes Mayor Gregory Horan to execute such agreement. Carried as follows
